ANR Pipeline Company (“ANR”), pursuant to Section 4 of the Natural Gas Act and Part 154 of the Federal Energy Regulatory Commission’s (“FERC” or “Commission”) regulations,¹ submits for filing certain revised tariff sections, as Appendix A, to be part of its FERC Gas Tariff, Third Revised Volume No. 1 (“Tariff”).² The purpose of this filing is to update ANR’s system maps in compliance with the annual filing requirements in Section 154.106 of the Commission’s regulations. ANR respectfully requests that the Commission accept these revised tariff sections to become effective June 1, 2014.

Statement of Nature, Reasons and Basis for Filing

Section 154.106 of the Commission's regulations requires that pipeline tariffs include a map showing the general geographic location of principal pipeline facilities and points where service is rendered. Furthermore, the regulations require that pipelines revise existing maps to reflect major system changes. Accordingly, ANR is submitting the instant filing to update its system maps to reflect such changes for the calendar year ending December 2013.

Effective Date

ANR requests that the Commission accept the revised tariff sections filed herein and included as Appendix A, to become effective June 1, 2014.

There are no other filings before the Commission that may significantly affect the changes proposed herein.

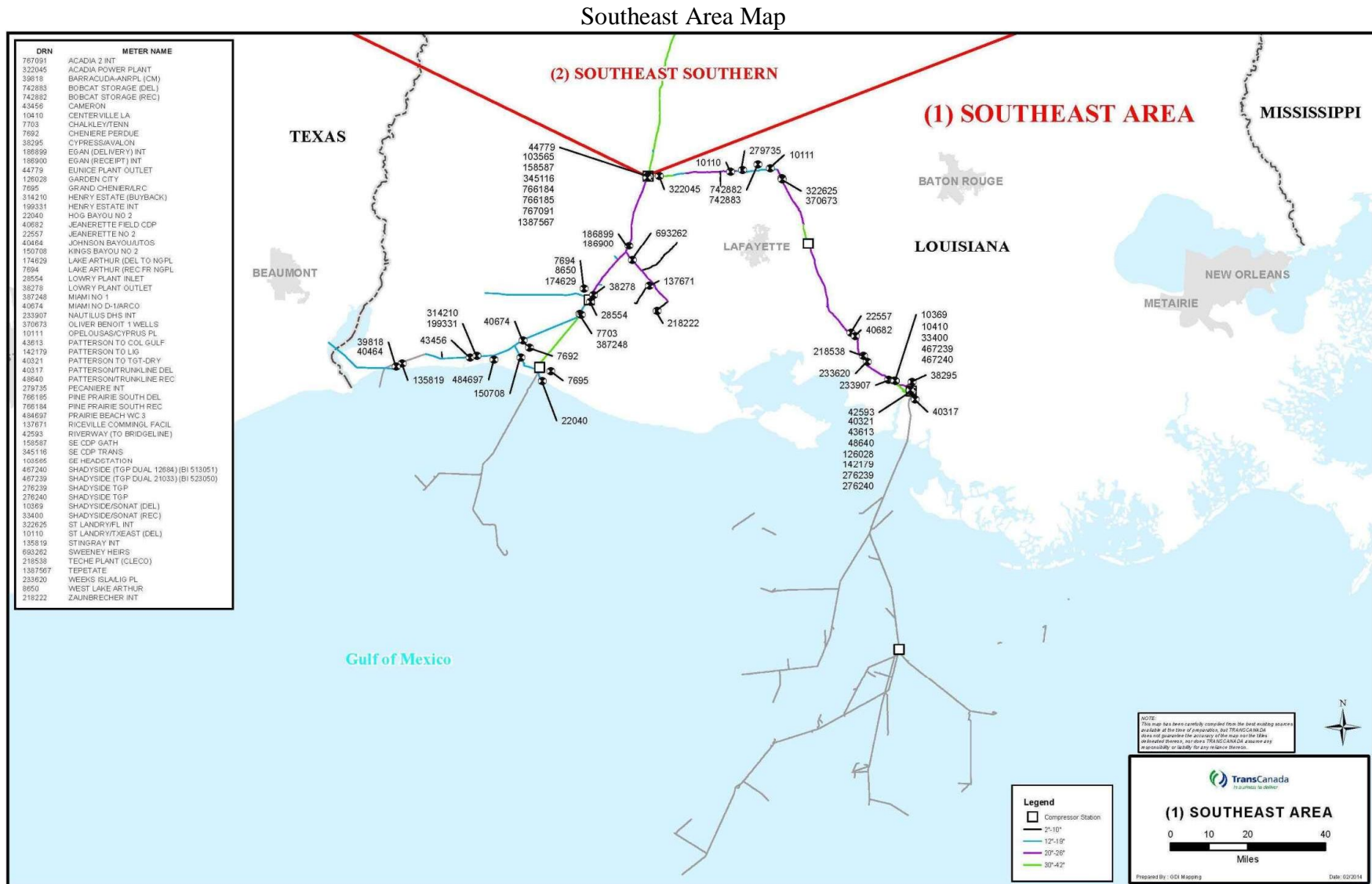

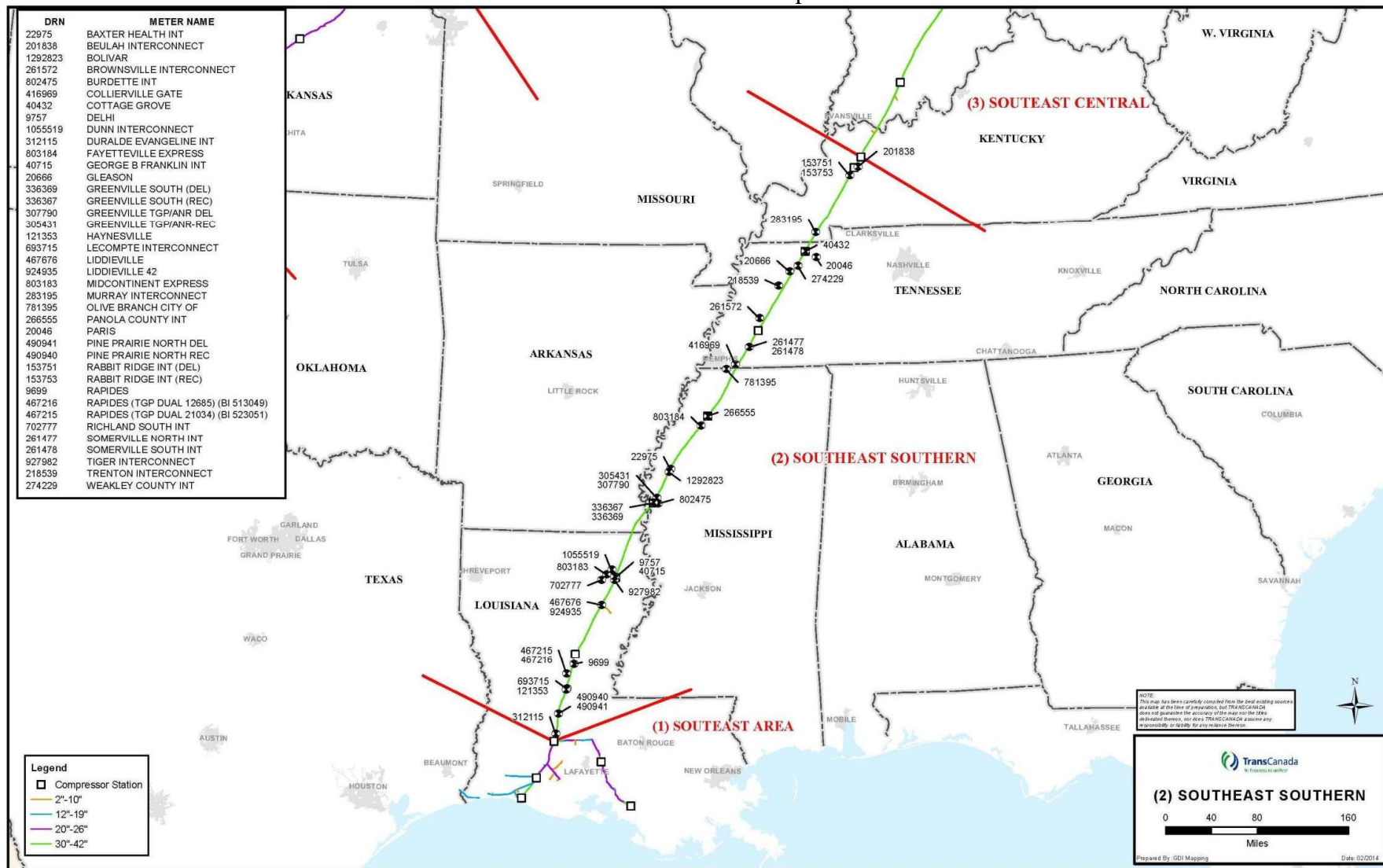

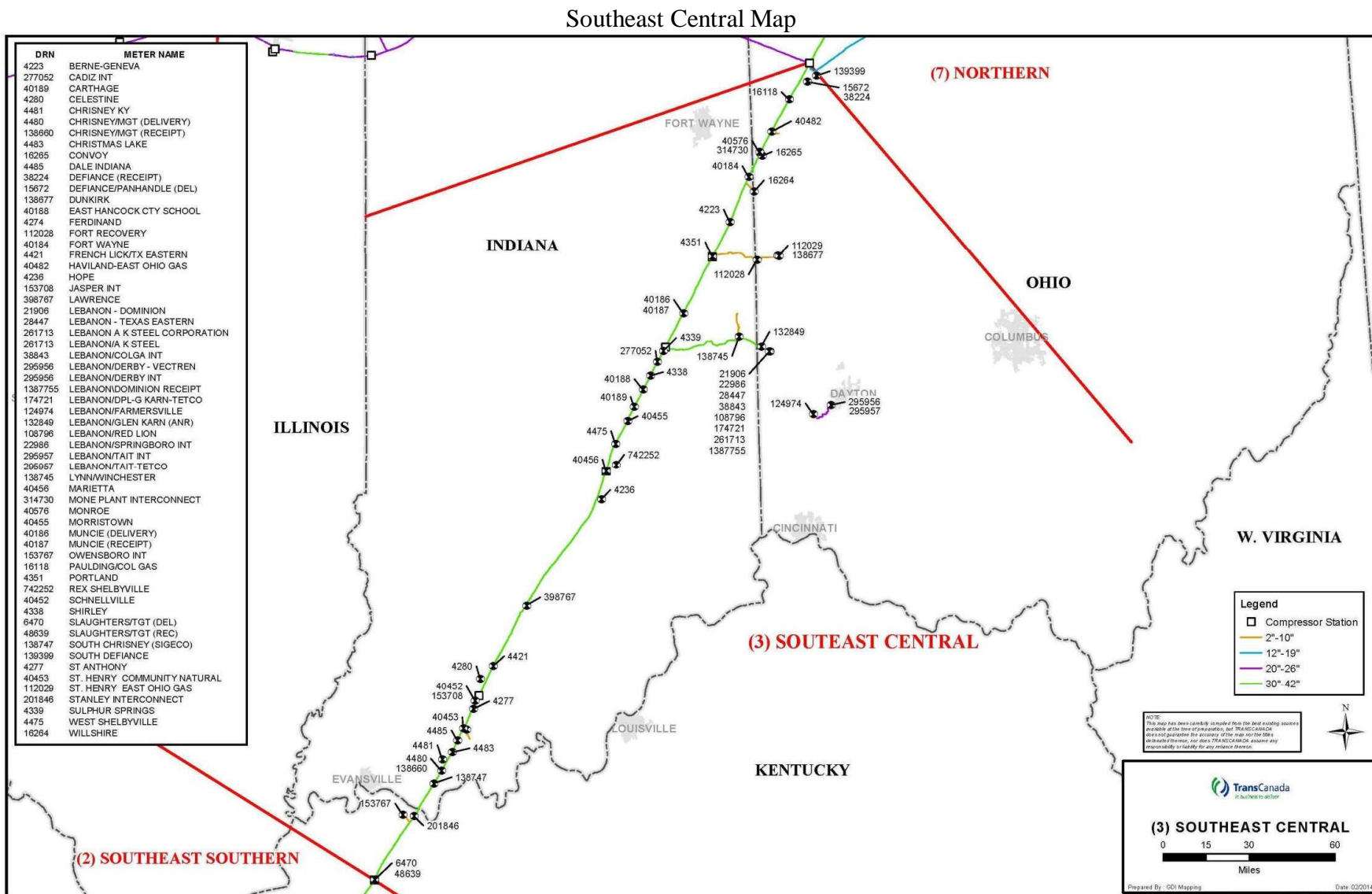
Area Map

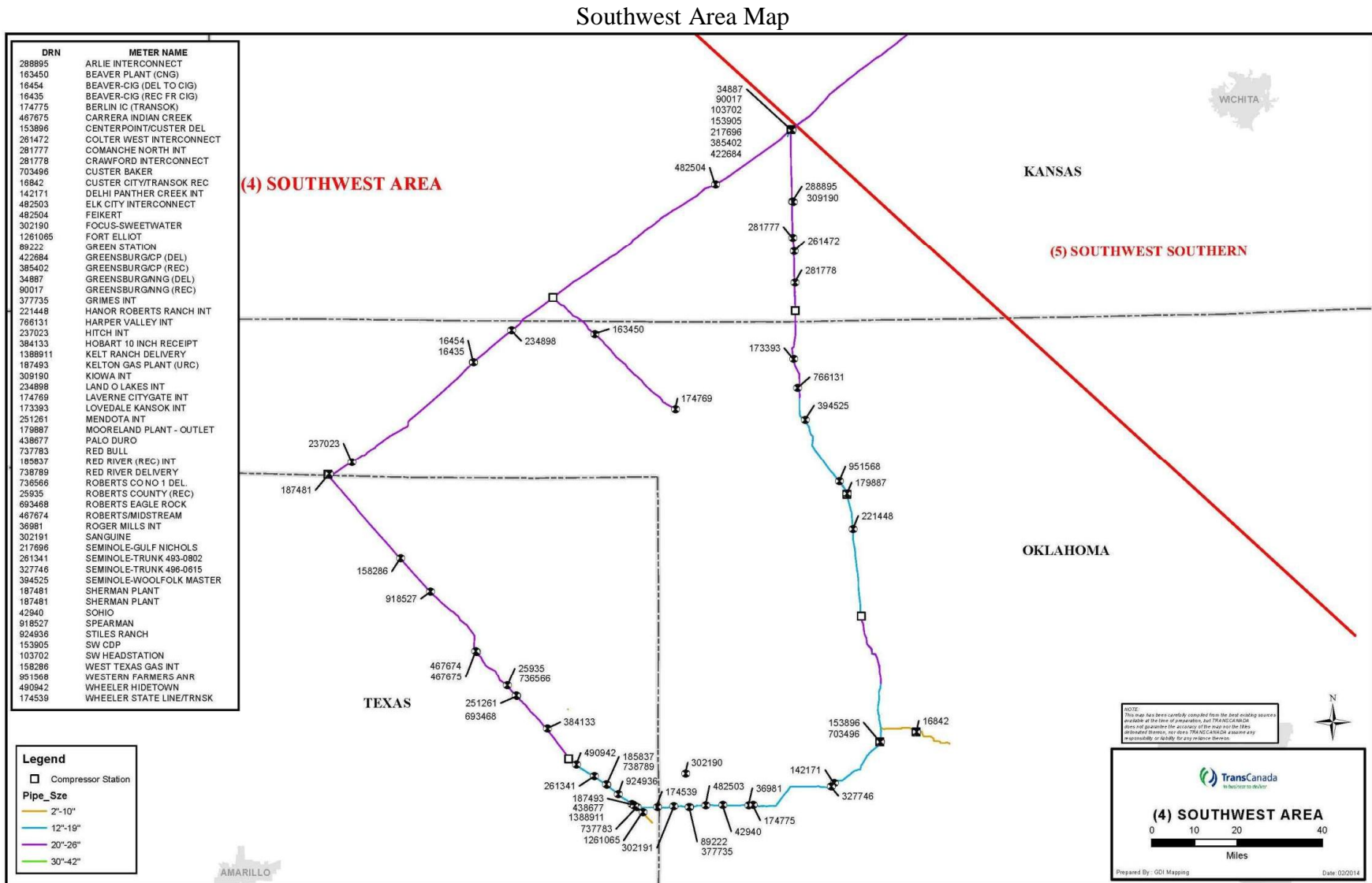




Southeast Southern Map







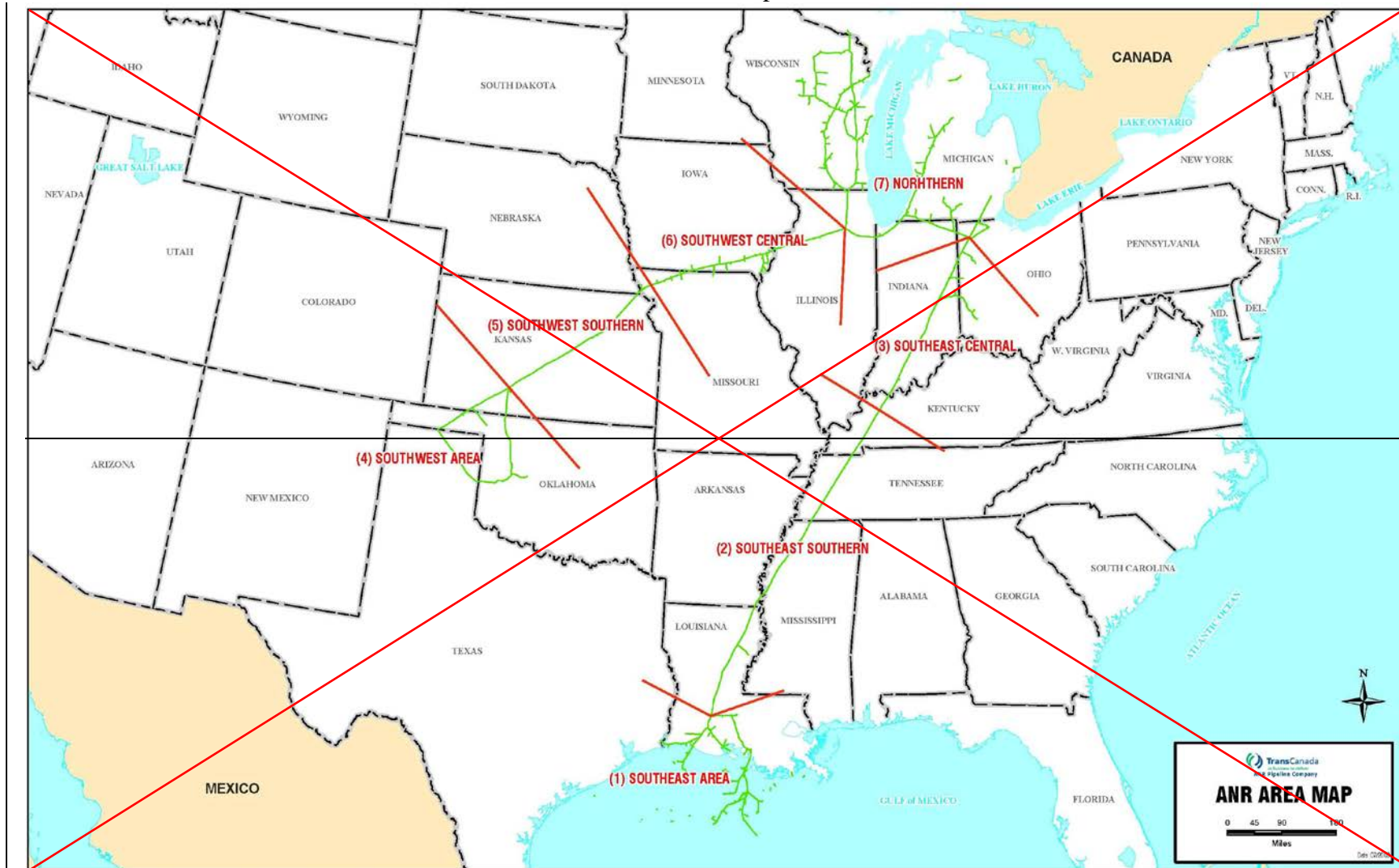

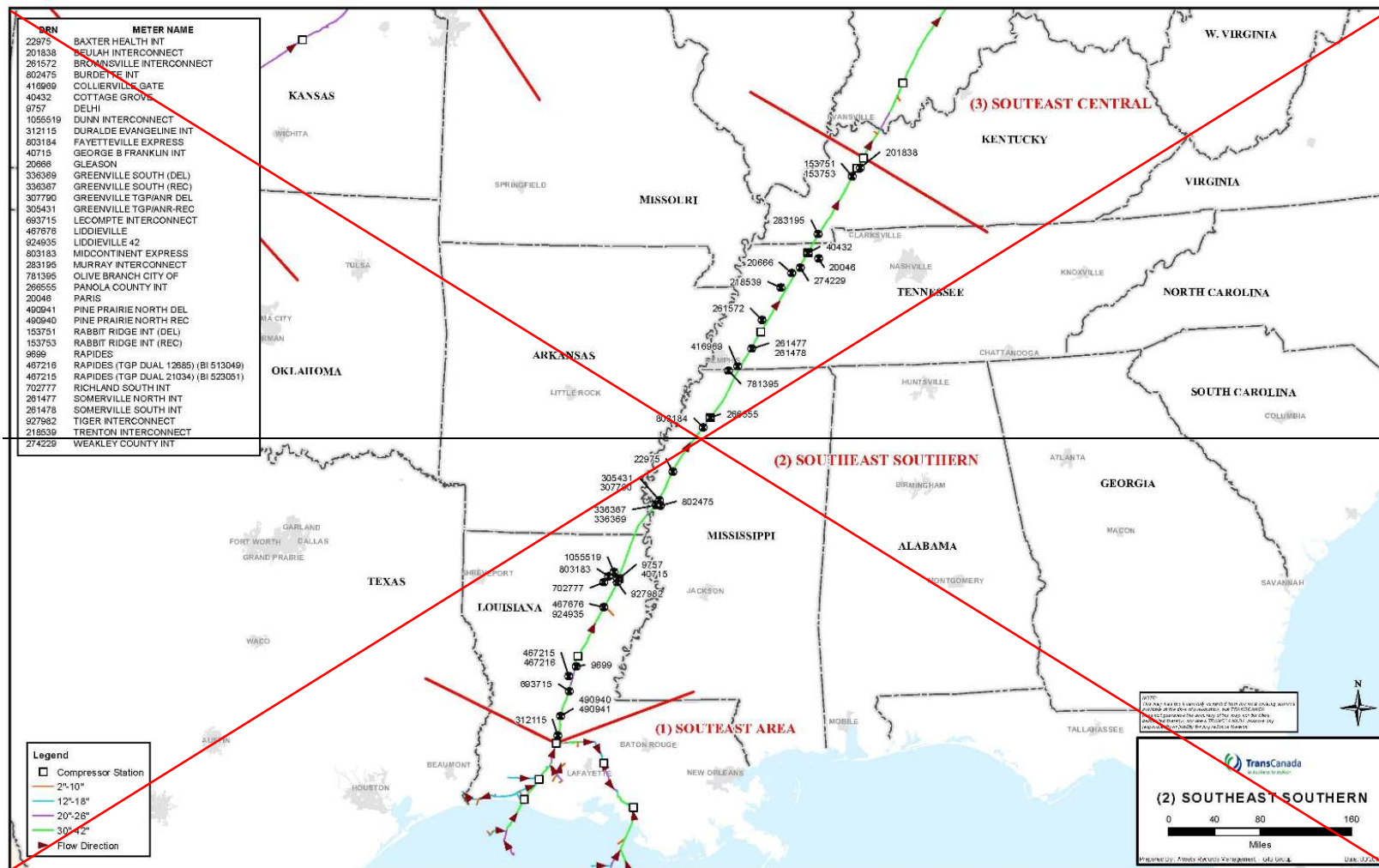

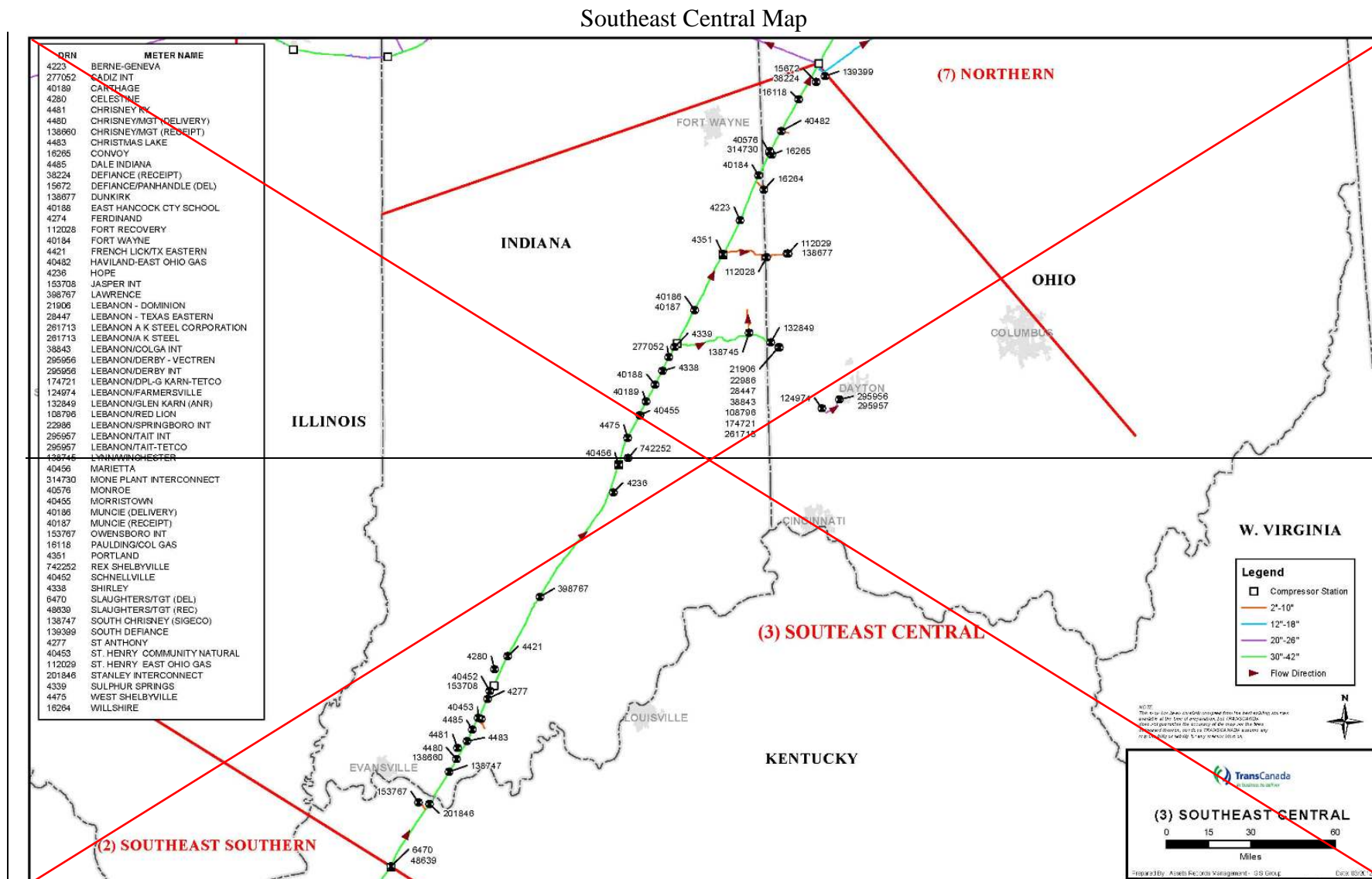
Area Map



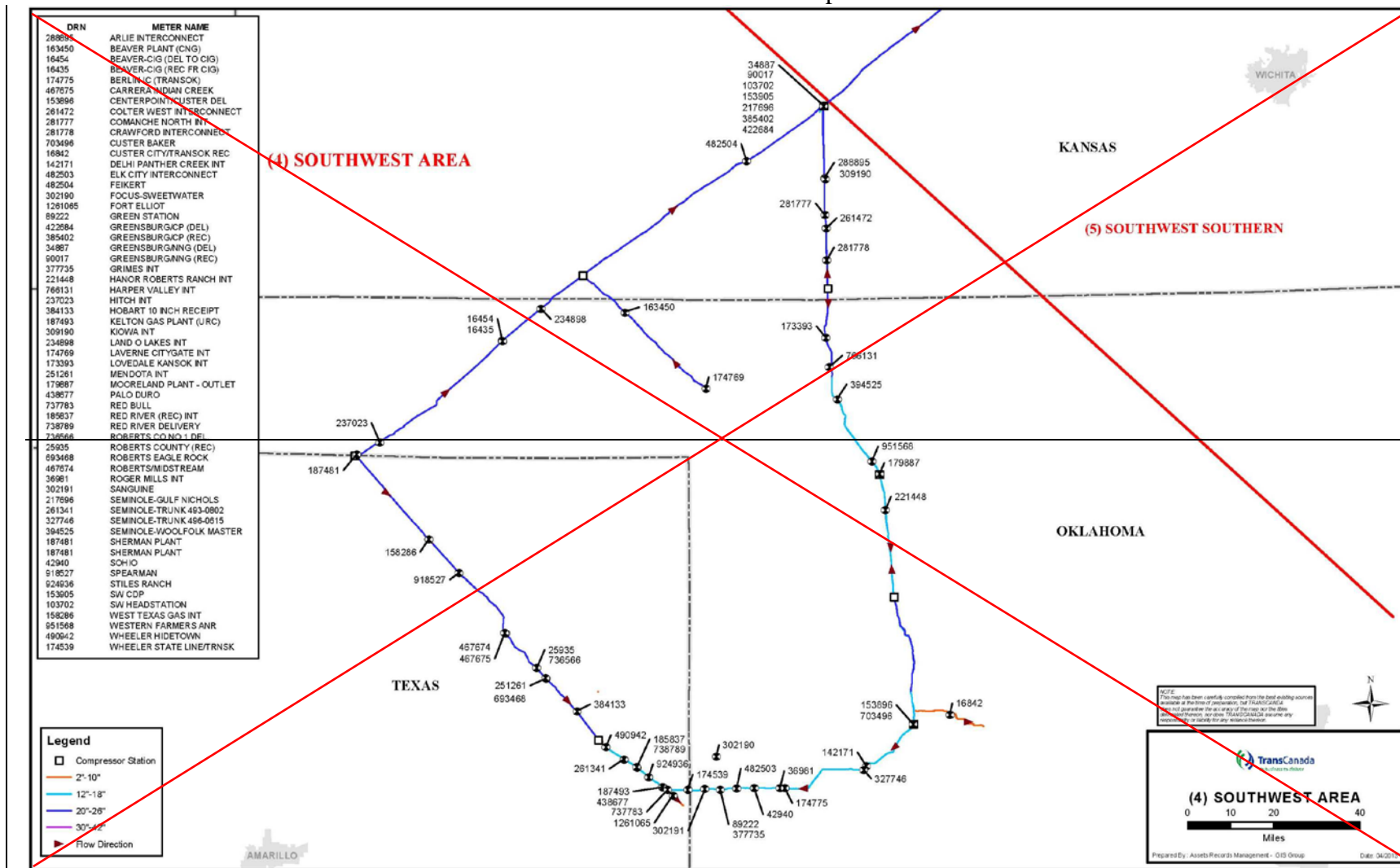


Southeast Southern Map
