Dear Ms. Bose:

On September 13, 2013, in Docket No. RP13-1326-000, ANR Pipeline Company (“ANR”) submitted Revised Tariff Sections¹ to comply with the 2011 Marshfield Settlement, which was filed on March 31, 2011, in Docket No. RP10-517-000 and approved by the Commission on August 4, 2011. In its September 13 filing, ANR stated that it expected to place the Marshfield Facilities² into service as early as September 30, 2013, but not later than October 18, 2013, and requested that the Commission accept the Revised Tariff Sections to become effective coincident with the in-service date of the Marshfield Facilities. For administrative ease, however, the Revised Tariff Sections submitted in the September 13 filing reflected an effective date of December 31, 9998, consistent with the Commission’s Implementation Guide for Electronic Tariff Filings.³ ANR stated that it would provide notification to the Commission of the actual in-service date, which also serves as the effective date for the Revised Tariff Sections.

On October 8, 2013, ANR submitted notice to the Commission that its Marshfield Facilities were placed into service on October 7, 2013.⁴ ANR respectfully requests herein that the Commission update the tariff records for ANR’s Revised Tariff Sections accordingly.
