Dear Ms. Bose:

Pursuant to Section 4 of the Natural Gas Act and Part 154 of the Federal Energy Regulatory Commission’s (“FERC” or “Commission”) regulations,<sup>1</sup> ANR Pipeline Company (“ANR”) submits for filing as part of its FERC Gas Tariff, Third Revised Volume No. 1 (“Tariff”), an amended Section 4.16 reflecting a proposed Cashout Price Negative Surcharge of (\$0.0021)/Dth.<sup>2</sup> Amended Section 4.16 is being submitted to reflect the effect of the anticipated Commission’s approval of ANR’s motion to withdraw (the “Motion”) its tariff filing filed with the Commission on December 28, 2020 in Docket No. RP21-340-000 (“2020 Filing”) as further described below. ANR respectfully requests that the Commission accept the amended Section 4.16, included as Appendix A, to become effective June 1, 2022.

### **Statement of Nature, Reasons and Basis for Filing**

Section 6.15.5 of the General Terms & Conditions (“GT&C”) of ANR’s Tariff<sup>3</sup> sets forth the System Cashout Mechanism. The System Cashout Mechanism provides for an annual calculation, on a system-wide basis, of a cashout surcharge (positive or negative) reflecting annual cashout activity.

On April 12, 2022, ANR submitted the Motion to withdraw its entire 2020 Filing, which included changes to Section 6.15.5 and Section 6.15.1.<sup>4</sup> As explained in the Motion, the driving force behind the proposed tariff changes in the 2020 Filing was removed when Transcontinental Gas Pipe Line Company (“Transco”) and the participating parties reached a settlement in Docket No. RP20-618-000, *et al*, that affected the cashout-related amounts that ANR intended to capture in the 2020 Filing. Accordingly, ANR elected to withdraw the 2020 Filing and file revised tariff records for Section 6.15.1 and Section 6.15.5 reflecting the removal of the tariff language modifications proposed in the 2020 Filing, which became effective per the Commission’s January 2021 Order on February 1, 2021. No comments or protests to the Motion were filed to the docket. On April 29, 2022, ANR filed its Annual Cashout Surcharge in Docket No. RP22-864 (“April 29 Surcharge Filing”) in accordance with the currently effective Tariff provisions, which include the modifications submitted in the 2020 Filing. In anticipation of the Commission’s approval of the Motion, ANR is submitting amended Section 4.16 along with the supporting workpapers to reflect the removal of tariff language modifications proposed by ANR in the 2020 Filing.

Attached hereto as Appendix C is ANR’s annual report of net cashout activity on its pipeline system that is based on the cashout provisions in Sections 6.15.5 and 6.15.1 that were in effect prior to the 2020 Filing. Attachment 1, Page 1, of this report reflects the calculation of the 2021 Net Cashout Activity Balance, made up of a beginning positive cashout balance (*i.e.*, revenues in excess of costs) of \$694,096, net positive cashout activity during calendar year 2021 of \$3,741,463 (*i.e.*, revenues in excess of costs), and negative surcharge reimbursements by ANR in 2021 of \$534,614. After including carrying charges, the Net Cashout Activity balance on December 31, 2021 used to develop the surcharge is \$4,025,057.<sup>5</sup>

Consistent with Tariff Section 6.15.5(c), ANR has calculated a Cashout Price Negative Surcharge of (\$0.002080)/Dth, which rounds to a rate of (\$0.0021)/Dth, by dividing the Total Cashout Activity balance by the system throughput actually experienced and reported in ANR's 2021 FERC Form No. 2. Accordingly, as set forth in Section 4.16 of attached Appendix A, ANR proposes to revise the surcharge of (\$0.0022)/Dth proposed in the April 29 Surcharge Filing to (\$0.0021)/Dth, to become effective June 1, 2022.<sup>6</sup> This surcharge shall be applied to all transportation services subject to surcharges.

ANR is enclosing herewith the detailed schedules, in Appendix C, that derive the Cashout Price Negative Surcharge rate of (\$0.0021)/Dth.

- Amended Attachment 1 sets forth a monthly summary of the net cashout activity on a system-wide basis for the period January 2021 through December 2021 (pages 2 - 5), and in total for the twelve-month period (page 1). Deficient Quantities are shown as positive entries and Excess Quantities are shown as negative entries. Page 1 summarizes the cashout activity during this twelve-month period, and also provides the calculation of the Cashout Price Negative Surcharge.
- Amended Attachment 2 sets forth the calculation of carrying charges on the monthly net cashout activity in accordance with Section 154.501 of the Commission's regulations.
- Amended Attachment 3 summarizes the spot price indices for Louisiana, Oklahoma, Canada, and the ANR Mainline for the period January 2021 through December 2021.
- Amended Attachment 4 includes a listing of all actual replacement gas purchases and sales, including volume and amount, by entity.
- Attachment 5 includes a detailed report of monthly net volume imbalances cashed out (bought or sold), including applicable cashout prices, and the applicable cashout gas costs or cashout revenues, by shipper and by receipt area, for the period January 2021 through December 2021.

#### **Effective Date and Waiver**

In accordance with Section 154.7(a)(9) of the Commission's regulations, ANR respectfully requests that the Commission accept the amended Section 4.16 and the Cashout Price Negative Surcharge, included herein as Appendix A, to become effective June 1, 2022. ANR respectfully requests that the Commission grant any waiver that it may deem necessary to accept this filing and to place the tariff records into effect as requested herein.


