Notification to Effectuate Tariff Section

Dear Ms. Bose:

On September 4, 2015, in Docket No. RP15-1257-000, ANR Pipeline Company (“ANR”) submitted a revised tariff section¹ to its FERC Gas Tariff, Third Revised Volume No.1 (“Tariff”), to comply with the Commission’s December 2, 2014, Order Issuing Certificate in Docket No. CP14-514-000 and the Commission’s July 7, 2015, Order Denying Rehearing in Docket No. CP14-514-001 regarding incremental fuel rates for ANR’s Sulphur Springs Compression Project (“September 4 Filing”). In its September 4 Filing, ANR stated that it expected to place facilities into service on or about October 15, 2015, and requested that the Commission accept the revised tariff section to become effective on the date the facilities are placed in-service. For administrative ease, the revised tariff section submitted in the September 4 Filing reflected an effective date of December 31, 9998, consistent with the FERC’s Implementation Guide for Electronic Tariff Filings.² ANR stated that it would provide notification to the Commission of the actual in-service date, which would be the effective date for the revised tariff section. On October 22, 2015, the Commission issued an order accepting the September 4 Filing and required that ANR submit this informational filing via eTariff when it submits its notice of in-service in compliance with section 154.20(c)(2) of the regulations.³
